

Subject: Updated Note Re: Printing of Certified List

Aloha Bill: I apologize for any confusion which this email will generate. This email will take the place of an email which I sent to you yesterday concerning the printing of the certified list. Previously I advised you to prepare a check made out to the Council for Native Hawaiian Advancement. After discussing this matter further with Governor Waihee it was decided that it would be preferred if you paid our IT contractor directly rather than issuing a check to CNHA. Olin and Donovan (ASIO), the Native Hawaiian Roll Commission passed the following action during their meeting on July 10, 2015: "Move to certify the list of qualified native Hawaiians compiled by the Native Hawaiian Roll Commission pursuant to HRS Chapter 10H, as of July 10, 2015." It is likely that additional certified names will be added to the list by the Roll Commission between now and the date established by Nai Aupuni for delegate elections. The Roll Commission will need to certify these names at future meetings of the Commission and they will be forwarded to Nai Aupuni. ASIO is authorized to provide an electronic file to Nai Aupuni in a format which has been agreed to by ASIO and Nai Aupuni. Further, ASIO is authorized to assess from Nai Aupuni the cost it will incur to produce this electronic file. Our understanding is that the estimated amount required to produce the list is \$5,000. Please confirm this amount with Mr. Meheula and Mr. Asam.

Furthe, ASIO should be advised that at its meeting on July 10th the Roll Commission also established that Nai Aupuni is the type of independent group envision in Act 195, 2011 and this is the basis upon which authority is given to provide them with a copy of the certified list.

HAWAIIAN ROLL COMMISSION FILED FEBRUARY 18, 2015

Applicant JUDICIAL WATCH, INC.'S Application for an Order Allowing Inspection of Public Records of the State of Hawaii I Native Hawaiian Roll Commission, filed February 18, 2015 ("Application") came on for hearing on June 3, 2015 at 9:00 a.m. before the Honorable Jeannette Castagnetti. Appearances were made by Michael A. Lilly, Esq., on behalf of Applicant JUDICIAL WATCH, INC. and Stella M.L. Kam, Esq., appeared on behalf of Respondents CLYDE W. NĀMU'O, and STATE OF HAWAII NATIVE HAWAIIAN ROLL COMMISSION. There were no other appearances.

Having considered the Application, arguments of counsel, the evidence submitted by the parties, the exhibits, records and files in this case, for the reasons stated in open court, and good cause appearing therefor,

The Court concludes that the Respondents' list of the names of over 125,000 registered applicants is a government record under HRS, §92F-3, and the list of names only is not otherwise exempt from disclosure under Chapter 92F, HRS.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Application is GRANTED as follows:

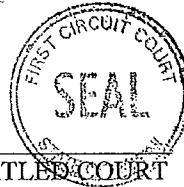
1. Respondents shall produce to Applicant its complete list of the names of over 125,000 registered applicants, also known as the Kana'iowalu, in either electronic form or hard copy within 10 working days of the entry of this order. The list disclosed shall consist of the names of the registered applicants and not their personal information such as telephone numbers, mailing addresses or email addresses.

2. The Court will award Applicant reasonable attorney fees and costs pursuant to HRS, §92F-15(d), upon a non-hearing motion for same.
